

**Monroe-Gregg Board of School Trustees
Minutes of the Regular Meeting
Administration Office
August 12, 2013**

The regular meeting of the Monroe-Gregg Board of School Trustees began with the Pledge of Allegiance.

CALL TO ORDER

The meeting was called to order by Board President, Mr. Jack Elliott at 6:32 P.M., in the Administration Office conference room. Board members in attendance were: Mrs. Nancy Dorsett, Mr. Tim Pridemore, Mr. Jim Shields and Mr. Jack Elliott. Also attending were Dr. William Roberson, Superintendent; Kelly Dillon, Corporation Treasurer; and Mr. Steve Harris, Corporation Attorney. High School Principals, Mike Springer and Athletic Director, Brian Lewis were all in attendance. Representatives from the Monroe-Gregg Teachers Association and several additional Monroe-Gregg employees were also present. Mr. Scott Everett was unable to attend.

CONSIDERATION OF MINUTES

The motion was made by Mrs. Nancy Dorsett to approve the following minutes as presented:

Mr. Tim Pridemore seconded the motion and the motion carried 4-0.

CONSIDERATION OF CLAIMS

Board President, Jack Elliott asked if there were any changes to the claims report as presented, there being none, Mr. Shields made the motion to approve claims #765 through #877 in the amount of \$1,154,346.35 as presented. Seconded by Mr. Pridemore, the motion carried 4-0.

CONSIDERATION OF PERSONNEL RECOMMENDATIONS

Dr. Roberson recommended the Board approve the Personnel Report as presented. The motion to approve was made by Mr. Shields, seconded by Mr. Pridemore, motion carried 4-0.

PUBLIC COMMENT ON AGENDA ITEMS

There were no comments on agenda items.

CONSIDERATION OF COLLECTIVE BARGAINING AGREEMENT

Dr. Roberson stated he enjoyed working with the Monroe-Gregg Teachers Association to reach a two year contract agreement. He recommended the Board approve the contract agreement reached by both parties including two letters of assurance. (contract & letters of assurance attached)

Mrs. Dorsett made the motion to approve as presented, seconded by Mr. Pridemore, motion carried 4-0.

CONSIDERATION OF SAFETY GRANT

Dr. Roberson asked permission from the School Board to apply for a grant to help with safety and security. The grant is from Homeland Security and is a matching grant. Monroe-Gregg will also partner with Mooresville Schools for a separated grant. The grant is for \$50,000 and the partner grant is also an addition \$50,000.

Mr. Shields made the motion to allow Monroe-Gregg to apply for both grants. Mrs. Dorsett seconded the motion and the motion carried 4-0.

CONSIDERATION TO WAIVE RETIREMENT DATE NOTIFICATIONS

Mrs. Kay Korty and Mrs. Wavely Bettenhausen requested to have the 120 day requirement notification for retirement waived. Mr. Pridemore made a motion to waive the number of days required for notification, seconded by Mr. Shields, motion carried 4-0.

CONSIDERATION OF ADMINISTRATOR AND CLASSIFIED HANDBOOK CHANGES

Dr. Roberson asked the board for permission to remove the following paragraph from page four (4), which is no longer applicable in the M-GSD Administrator & Classified Handbook.

~~“Certified Elementary Assistant Principal hired prior to February 9, 2010 and after will be offered a Health Savings Account Contribution at the following cap amounts:”~~

Mr. Shields made the motion to approve the change to the handbook as presented. Mr. Pridemore seconded the motion and the motion carried 4-0.


MISC
