

**Monroe-Gregg Board of School Trustees  
Minutes of the Regular Meeting

December 13, 2010**

The regular meeting of the Monroe-Gregg Board of School Trustees began with the Pledge of Allegiance.

**CALL TO ORDER**

The meeting was called to order by Board President, Mr. Jim Shields at 6:40 P.M., in the Administration Office conference room. Board members in attendance were: Mr. Jack Elliott, Mrs. Nancy Dorsett, and Mr. Tim Pridemore. Also attending were Dr. Julie Wood, Superintendent and Mr. Steve Harris, Corporation Attorney. Vice-President, Scott Everett was unable to attend.

**CONSIDERATION OF MINUTES**

School Board President, Jim Shields called for a motion to approve the minutes of the regular meeting for November 8, 2010. The motion was made by Mrs. Nancy Dorsett to approve meeting minutes as presented, seconded by Mr. Tim Pridemore; motion carried 4-0.

**CONSIDERATION OF CLAIMS**

Mr. Tim Pridemore made the motion to approve claims #13505 through #13640 in the amount of \$1,760,111.77 as presented. Mr. Jack Elliott seconded and the motion carried 4-0.

**CONSIDERATION OF PERSONNEL RECOMMENDATIONS**

There were no changes or additions to the personnel report. The motion to approve the personnel recommendations as presented was made by Mr. Tim Pridemore, seconded by, Mrs. Nancy Dorsett, motion carried 3-1. The descending vote was cast by Mr. Jack Elliott

**HIGH SCHOOL PRESENTATION**

High School Principal, Jacob Hagist provided a brief overview of the new Green Initiatives under way in the Monroe-Gregg School District. They will pay for any custodian expenses incurred by the school district. The motion to approve the request was made by Mrs. Nancy Dorsett, seconded by Mr. Tim Pridemore, motion carried 3-1. The descending vote was cast by Mr. Jack Elliott.

This is a routine end of the year agenda item that allows the corporation treasurer to make the necessary fund transfers. Mr. Tim Pridemore made the motion to approve, seconded by Mrs. Nancy Dorsett, motion carried 4-0.
