The USDA has extended the waivers allowing schools to feed students for free through the school year 2021-22. The waiver also allows schools to provide free meals to all students during the summer break.

The Food Service Department at Monroe-Gregg School District will be preparing free grab and go meal bags for pickup or delivery for any students that wish to participate. **It is important that you sign your child up by email at emalone@mgdsd.org or call 317-996-2246 ext. 4402.** Breakfast and Lunch Entrées will come frozen and include simple cooking instructions. Meal bags will also include fresh and canned fruits and vegetables, chocolate milk and Juice for each day. There will be multiple days of meals given at each distribution.

Pick up will be at the main entrance to the Elementary School. If you choose delivery, a school bus will deliver your meals between 1pm-3pm on each delivery date. Because the food needs refrigeration, it is important that someone be home to receive each delivery.

The schedule for pickup/delivery at this time is:

- Wednesday June 2, 2021 1pm. (4 days of Breakfast and Lunch will be given to each student)
- Monday June 7, 2021 1pm. (3 days of meals for each student)
- Wednesday June 9, 2021 1pm. (4 days of meals for each student)
- Monday June 14, 2021 1pm. (3 days of meals for each student)
- Wednesday June 16, 2021 1pm. (4 days of meals for each student)
- Monday June 21, 2021 1pm. (3 days of meals for each student)
- Wednesday June 23, 2021 1pm. (4 days of meals for each student)
- Monday June 28, 2021 1pm. (3 days of meals for each student)
- Wednesday June 30, 2021 1pm. (4 days of meals for each student)

A schedule for July will be posted at a later time.

We want to encourage every student to participate regardless of financial need. Participation helps Monrovia families, the community, and it funds the school food service program.
