

Chromebook FAQ

Is my student required to use a school issued device?

Yes, all students will be required to use a school issued device. This device is the property of M-GSD. The device supports learning platforms used by teachers to facilitate a blended learning environment for all students. The technology department monitors the use of the devices and utilizes safety measures to insure our students are using the technology appropriately and safely. Each student will also receive a padded case and shoulder strap for the device.

Do I have to sign the waiver to get the device?

Yes, all parents must sign the waiver and pay the waiver fee for the device to be distributed to the student. **If your student qualifies for free / reduced book rental, please contact your building principal to apply for waiver assistance.** *Each student will need a waiver form and fee on file before a device will be issued to the student.*
